The following table lists calculated effects of benefit changes by type of injury. **In many cases, the benefit changes reflected in this table measure only that portion of the annual changes in indemnity benefits attributable to annual changes in the maximum and minimum benefit levels made in accordance with changes in the statewide average weekly wage.** Some of the entries in the exhibit, identified with specific footnotes, reflect the effects on medical benefits due to the enactment of specific legislation including Senate Bill 1 of 2007, Senate Bill 238 of 2012, House Bill 175 of 2013 and House Bill 373 of 2014.
