Loss Based Assessments and Employer Assessment Factor

The Administration Fund, Subsequent Injury Fund, Supersedeas Fund, and Uninsured Employers Guaranty Fund are not included in the loss costs but are a separate charge to the insured. The attached exhibit presents detail of loss payments, budgeted expenditures and the resulting assessment levels. The indicated Employer Assessment Factor is 2.18%, a decrease of 0.04% from the current value of 2.22%.

Also presented in this exhibit are the Small Business Advocate assessment as well as charges for the Merit Rating Plan and Certified Safety Committee Program. These three items are included as part of the published loss costs. A factor of 1.26% is proposed as a load to loss costs for those items. The current factor is 1.33%.
